Income Tax Returns

Is Self-Assessment too taxing to do by yourself?

You would need to register for a self-assessment tax return if any one of the following criteria is met:

- you're self-employed, a business partner, or director of a limited company
- you're an employee or pensioner with an annual income of £100,000 or more
- you have a pre-tax investment income of £10,000 or more
- you were a trustee of a trust or registered pension scheme
- you are a trustee or representative of someone who died
- you have untaxed savings or investment income
- you own land or property that is being let
- your household receives Child Benefit and you have income in excess of £50,000
- you have sold or given an asset away (such as a holiday home or some shares) and need to pay Capital Gains Tax (CGT)
- you've lived/worked abroad or aren't domiciled in the UK
- you need to disclose income that has not been taxed here or abroad in the past

With HMRC changing rules & regulations regularly, at Taxfile we can ensure that you only pay the correct amount of tax needed.
